Publication Guidelines

Shaqra University Journal is a referred academic periodical journal published by Shaqra University with the aim of providing researchers with an opportunity to publish their research work in various areas of academic research. The Editorial Board examines the relevant research papers that would be published in the Journal on condition that these research works have not been published before.

The author(s) has the full responsibility of his (their) research work in tune with the validity of the research topic and the used references. The research papers should express the views of the researcher(s) and of the research conclusions arrived at. The SUJ publishes the following:

- Authentic research papers in the fields that are of interest to the Journal.
- Review Articles that critically deal with prior research work.
- Book Reviews.

General Remarks

- The Journal has the right to make the necessary amendments of the submitted research articles and according to the publication guidelines. Research articles would be written in the Arabic or English Language. Titles and abstracts should be presented in the Arabic language if the research paper is written in English and, in Arabic if the research paper is written in English.
- The research paper should be submitted in its final form including charts, tables and forms within the content of the research serially numbered, using the MS Word Program and Arabic Transparent. This is done with font 16 for the content, 14 for the Footnotes and Endnotes. the abstract has to include in brief idea about the topic, the methodology of research and the most important results in about 250 words. The research article should be sent in the MS-word program and PDF on the Journal Email Address.
- The title of the article, name(s) of the authors, position, institution, area of interest and address should be presented in both Arabic and English.
- Tables and forms (if applicable) should be clear, organized and numbered according to its use in the main bulk of the research. They should be printed out in separate pages and the title of the table should be mentioned on top and the title down in a way that shows its content.
- There should be a use of abbreviations according to the international criteria. Footnotes should be used to inform the readers with the illustrations and the comment should be mentioned in the main bulk of the research.
- Print Off: Author(s) attains 10 Print Off copies for free of every research work.
- Articles is not returned to their owners, wither published or not.

References in English:

First: Referring to the Source in the written text immediately after the citation, including:

- Placed between parentheses, and mentions the last name of the author, year of publication, and page number, such as: (Gant, 1979: 7), (Bokus, 1418H: 201), (Elhadi *et al.*, 2010).
- If you use more than one writer referring to one author and the source was published in the same year, one should give the first symbol (a), and the second code (b). For instance: (Ali, 1980a: 42) and (Ali, 1980b: 89).

Second: arrange the names alphabetically in the list of references at the end of the Research work:

- Books with one author: Last Name, First Name and Middle (year of publication) the title of the book, the Publisher, Place of publication, Edition, if any.
- Books with Two authors: last name first, first name, middle, second last name, first name and Middle (year of publication) the title of the book, publisher, place of publication, Edition, if any.
- Books with three or more authors: Last Name, First Name and Middle, and others (year of publication) the title of the book, publisher, place of publication, Edition, if any.
- A chapter or a study is included in the book: name, first name (year of publication) search title, the name of the editor, the book's title, place of publication, pages.
- Periodicals: last name, first name (year of publication) the article title, the name of the periodical, volume number and page number.
- Unpublished works: Last Name, First Name (publication year) Research title, Research specialization, university or institution, place, pages.
- Translated books: Last Name, First Name (year of publication) the title, the name of the translator year of publication, publisher, place of publication.
