

Comprehensive Nursing Review Program for Successful SNLE

Step-by-Step Guide for Students

1. You should register through this Google Form (<https://forms.gle/bHQ5cX4gBFaPWZhK9>) before November 28, 2020.
2. You should create an account at <https://su-lms.com/login/> before November 28, 2020.

Please make sure to follow the following:

- a. Use the email address that you put in the registration form,
 - b. Use your student/ University ID as your username,
 - c. Make sure that you confirm your account through your registered email.
3. After you create your account at <https://su-lms.com/login/>, the members of the SNLE Review Committee will enroll you in the online course “Comprehensive Nursing Review Program for Successful SNLE”. If you were not enrolled in the online course within 24 hours after your registration, please contact SUSNLEReview@gmail.com.
4. Once you are registered in the online course, go through the online course to be familiar with it. Read the “Comprehensive Nursing Review Plan” to become familiar with the entire review program.
5. Take the Pre-Test Exam. Remember that the following in taking the Pre-Test Exam:
 - a. The Pre-test exam will only be open from November 28, 2020 at 6:00 pm to November 29, 2020 at 6:00 pm (24 hours).
 - b. You are given 195 minutes (3 hours and 15 minutes) to complete the exam.
 - c. Click “Online Pre-Test” located under “General Orientation”.
 - d. You are allowed only to take the pre-test one time.

6. For every topic, you will need to take the Practice Tests, which are scheduled from 12:00 noon to 4:00 pm on the same day of the review. You are given 90 minutes to finish the Practice Tests. For example, for Fundamentals of Nursing, you will need to take the Practice test on November 30 between 12:00 noon to 4:00 pm.
7. You must attend the rationalization and discussions on the different nursing topics from 6:00 pm to 9:00 pm via zoom

8. On December 17, 2020, you will need to take the Post Exam, which is divided into two parts. Part 1 is from 6:00 pm to 7:30 pm and Part 2 is from 7:45 pm to 9:15 pm.
9. You must complete the entire review program, pre-test, post-test, and practice tests to receive a CERTIFICATE OF COMPLETION.

Description:

The Comprehensive Nursing Review Program for Successful SNLE was designed to prepare graduating nursing students and nursing interns to pass the Saudi Nursing Licensing Exam (SNLE). This program provides a comprehensive review on the different concepts and areas of nursing, which are essential in passing the nursing licensure examination. The program was developed based on the latest test blueprint of the SNLE to ensure that the students are directed throughout the nursing concepts that are essential to pass the exam. The program will follow the “exam-rationale-discussion” strategy wherein for each subject; SNLE-like exams will be administered to the students, followed by the rationalization of answers and discussions of the concepts surrounding each question. Mock exams (pre-test and post-test) will be administered to the students at the end of the program to evaluate the progress of the students. The program also focuses in enhancing the critical thinking skills of the students, as well as their test taking strategies. The review will be delivered by the competent nursing faculty members of Shaqra University (1) who are specialized in the specific content areas and (2) who have first-hand experience of passing the SNLE or similar nursing licensing exams.

Objectives of the Program

The main objective of this nursing review program is to prepare nursing students in acquiring the Saudi nursing license to practice nursing professionally.

Specifically, it aims to:

1. Reinforce and enhance the knowledge of nursing students on the different nursing concepts;
2. Develop the critical thinking skills and test taking strategies of nursing students;
3. Enhance the nursing students’ confidence in interpreting, analyzing, making decisions, reasoning, and problem-solving during SNLE and other professional nursing exams;
4. Develop a positive attitude among nursing students in taking the SNLE and other professional nursing exams

Description of the Review Program Process:

1. The nursing students and interns must register through the members of the committee before the start of the review program schedule.
2. Once the students and interns had registered, they will be enrolled in an LMS (Moodle) of the review program.
3. The participants will then be instructed to answer the 150 multiple choice questions (MCQs) mock SNLE online. This will be the pre-test, and this will follow the format of

the SNLE. The mock SNLE will be divided into two parts of 75 questions, with each part lasting for 90 minutes. A 15-minute break will be provided before the start of the second part of the mock SNLE. The structure of the mock SNLE will follow the latest test blueprint of the SNLE. All the MCQs in the exam will have four (4) options where the students are asked to choose the one best answer.

4. During the review session of each nursing topic/ subject, the students/ interns will take a practice test consisting of 50 MCQs that represents all the important and essential concepts under each nursing topic/ subject. The students/ interns should take this test before the start of each review session. The speaker/ lecturer will rationalize/ explain the answer for each question. A deep and comprehensive discussion of the concept surrounding each question will be provided. For example, if question #1 in Fundamentals of Nursing is about infection prevention and control, the speaker/ lecturer will follow this process:
 - a. The speaker reads the question;
 - b. The speaker explains the context of the question and how to understand the question,
 - c. The speaker provides the answer and the rationale/ reason of the answer (as well as why the other options are incorrect);
 - d. The speaker provides a comprehensive discussion about infection prevention and control (or the specific nursing concept in the question); and
 - e. The speaker moves to the next question.
5. All the scores of the students/ interns will be recorded to track their development and to identify their areas of strength and weaknesses.
6. At the end of the review program, the students/ interns will take the mock SNLE (post-test) online. Similar to the pre-test, the post-test will follow the format of the SNLE. The scores of the pre-test and the post-test will then be compared to determine the progress and readiness of the students/ interns.
7. A final report will be provided to each student/ intern, as well as to the Deans (or head of department) regarding the overall performance of each student/ interns.
