## The rights and responsibilities of the student

The student must be provided every opportunity to go through higher education institutions smoothly. As a result, it includes duties that take the shape of obligations as well as rights that can only become actual when they are united.

#### Students' rights

- The student has a right to a top-notch education and research preparation. He is entitled to high-quality supervision while doing this, utilizing updated and modified instructional techniques.
- He must be provided with the course schedule at the start of the academic year. He must be given access to and made aware of the course materials (syllabus, book references, handouts, etc.).
- Members of the university community have a responsibility to treat students with respect and decency.
- The student cannot be treated differently based on their gender or any other characteristic. In line with the regulations governing educational institutions, students have the right to freedom of expression and opinion.
- The student has a right to a fair, equal, and unbiased evaluation. The delivery of the notes, together with the corrected and scale of the test, and, if required, the consultation of copy, must be made in acceptable timeframes that do not exceed those set by the pedagogical committees and the regulatory texts.
- If a student thinks a test adjustment is incorrect, he or she has the opportunity to appeal.
- Both on campus and in university housing, students are entitled to safety,

cleanliness, and health protection.

• The student has the right to have knowledge about the administrative and governing structures of the University.

The student gets access to the library, educational labs, computer resource center, and all other material resources needed for high-quality instruction.

The student freely and independently chooses his representatives for the educational committees.

Students may establish student organizations that are of a scientific, artistic, cultural, or sports nature in conformity with the laws currently in effect. Outside of the parameters established by the current legislation, these groups shall not intervene in the administrative and instructional management of the institution.

#### Students' Responsibilities:

The student is required to abide by the rules and regulations.

The student is expected to respect the integrity and decency of other students and faculty.

The student is required to respect the freedom of speech of other students and faculty.

The student is expected to respect the jury's decisions.

The student is required to register with accurate information and to fulfill his administrative and academic responsibilities to the institution and its structures.

The student must act with dignity and good manners on all occasions.

A student must never commit fraud or use plagiarism.

The student is required to maintain the space and resources at his disposal as well as adhere to the university's safety and sanitation policies in all buildings.

The university's administrative and academic institutions must remain open to students in all respects. They shouldn't be hampered in their work by utilizing students as a human barrier.

The student should be properly informed of the offenses leveled against him. The legislation in effect and the university's process guidelines outline the punishments he will face. They fall within the purview of the disciplinary councils and may result.
